<u>IC 35-42-4-3</u>	Child Molesting <sup>1</sup>	Any	Less than 14

<u>IC 35-42-4-4</u>	Child Pornography	Any	Less than 18
<u>IC 35-42-4-5</u>	Vicarious Sexual Gratification	18 or older	Less than 16
<u>IC 35-42-4-6</u>	Child Solicitation	18 or older	Less than 14
<u>IC 35-42-4-7</u>	Child Seduction	18 or older	16 or 17
<u>IC 35-42-4-8</u>	Sexual Battery	Any	Less than 18
<u>IC 35-42-4-9</u>	Sexual Misconduct with a Minor	18 or older	14 or 15
<u>IC 35-45-4-1(a)</u> <u>IC 35-45-4-1(b)</u>	Public Indecency	Any 18 or older	Less than 18 Less than 16
<u>IC 35-45-4-2</u>	Prostitution	Any	Less than 18
<u>IC 35-45-4-3</u>	Patronizing Prostitution	Any	Less than 18
<u>IC 35-45-4-4</u>	Promoting Prostitution	Any	Less than 18
<u>IC 35-46-1-3</u>	Incest	18 or older	Less than 18
<u>IC 35-42-3.5-1</u>	Human and Sexual Trafficking	Any	Less than 18

**Note:** When DCS receives reports that contain only criminal allegations (no CA/N allegations), the reports are “screened out” and transferred to law enforcement for investigation.

<sup>1</sup> The term does not include a child who is alleged to be a “child in need of services” if the child is alleged to be a victim of a sexual offense under IC 35-42-4-3 **unless** the alleged offense under IC 35-42-4-3 involves the fondling or touching of the buttocks, genitals, or female breasts. Cases that do not involve the fondling or touching of the buttocks, genitals or female breasts should be referred to law enforcement. (IC 31-9-2-14)
